### **OFFICIAL RULES**

- 1) Only children aged 5-7 are eligible to participate. Proof of age must be provided at the time of sign-up. Copy of birth certificate recommended.
- 2) The maximum weight limit for eligibility is 55 pounds, fully clothed. Weight will be determined by weighing-in at the time of sign-up. Due to the safety concerns of the stock, there will be no exceptions to this rule.
- 3) All contestants will be provided with a helmet and safety vest at the time of the competition.
- 4) The contestant and one parent will be provided with a general admission ticket to the performance.
- 5) All contestants shall receive a score regardless of the length of the ride and shall be scored by the announcer and one or more committee members.
- 6) Only one parent will be allowed in the holding area and arena per household.

2.
